Education Changes What's Happening Now?

He will also address our own climate changes and collaborations both locally and with the other Western states, in dealing with sustainability challenges.

Congress Approves Major Change to Handling of Military Sexual Assault

On December 19, the Senate passed a version of the annual defense and funding bill that includes major changes for the military's handling of sexual assault and rape. The bill, which the president is expected to sign, would end the statute of limitations for sexual assault cases, forbid commanders from overturning jury convictions, prohibit retaliation against people who report sexual assault; and give more control over prosecutions to civilian defense officials instead of military commanders.

Just hours after the Senate passed the bill, the President announced that he is giving the military one year to improve its handling of sexual assault cases or face even tougher reforms.

NB: The Defense Department's Sexual Assault Prevention and Response Office will have a new director in January. Major General Jeffrey Snow will take over when Major General Gary Patton <u>resigns.</u>

Mission Statement – AAUW advances equity for women and girls through advocacy, education, philanthropy and research.


