Genealogy: Who Are You?

A 20-year member of the National Genealogy Society, Jena served as a director for two years. For the past five years she has been a consultant at the Family History Center in Tualatin. She will teach us how to get started, how to do the research, where to go for specific information, and how to use specific sites. Be prepared to take notes!

The Shutdown and Women's Health

As it turns out, the government has "shut down" 17 times and four of the times (3 times in 1997, once in 1979), a disagreement about women's healthcare was responsible. Surprised? Well... it was as recent

as Saturday, October 12, that the House of Representatives passed legislation that would deny women preventative health care if their employers had a religious or moral objective. There was no provision to cut off men's preventative care. So prostrate exams are OK but potentially life-saving cancer screenings for women would need an employer's permission?

There are many things that went into the current shutdown, but it is clear that women's health played a role. The Affordable Care Act expands access to healthcare to millions of women who did not have it before. What we saw October 12th was one more attempt to make women's health a political bargaining chip.

Dear Donors,

Thank you very much for this award. While receiving a scholarship always helps take a weight off, it does so much more to raise my spirits. It is so easy to get bogged down in the day to day minutiae of school and family that the big goal seems distant and impossible. Your scholarship is a reminder of where I want to go, and an affirmation, that no matter how many papers I need to write or math problems I have to do, I can get there.

I'm a thirty-two year old married mother of two



amazing little girls. I decided to return to school to get my bachelor's and then go on to medical school to become a doctor. Medicine has been a thread throughout my adult life, from a serious car accident when I was twenty, to sitting with my best friend as she died of cancer, to having two children who were born premature and weighing less than four pounds. As I interacted with doctors I got to sample how medicine would demand all of me and pretty soon every other job failed to hold a candle to the prospect of becoming a physician, so I came to Portland Community College to ground myself in the basics while I decided which college would be best suited to my goal. Next year, we're looking to move to Corvallis so that I can attend Oregon State University and get a Bachelors in Biochemistry/Biophysics. In just three short years I hope to be getting my acceptance letter from Harvard Medical School.

As a 32 year old mother there are times when I feel this pressure inside to give up on my dream to become a doctor and instead find a job. I want my children to have a house, summer camps, and all the trappings of a middle class life. Scholarships like this remind me that my family and I are striving and sacrificing now in order to give my girls something more than stuff, a belief that they can achieve their dreams because they have seen me do it. Thank you so much for feeding that belief.
