**Women Business Owners Panel** 

Women make up more than 50% of the U.S. population, and they have grown to be 47% of the workforce. They have surpassed men in educational attainment, with over 33% of women having a bachelor's degree or higher. Women control \$14 trillion, or 51%, of U.S. personal wealth and are now the primary source of income in over 40% of households.

In 2012, women were majority owners of 9.9 million businesses which generated \$1.4 trillion in sales and employed over 8.4 million individuals. In addition, another 2.5 million businesses were equally-owned by women and men, and they accounted for another \$1.1 trillion in sales and 6.5 million jobs.

Please join us and meet four local business owners who are making a difference at work, at home and in their community.

Megan DeSalvo, Edge One Media, works in operations and marketing and is currently the Board Chair for the Tigard Chamber of Commerce.

Joan Edell, J&J CPAs, has been an owner in the business for over 25 years and is also active in our community.

**Cheri Frederickson, The Transformative Leader** is a professional coach for individuals and businesses and also owns and runs a second business to share her passion for fitness and balance at all ages as a Nia instructor.

Sarah Streeter, Specialty Heating and Cooling, along with her husband, is another long time Tigard business owner. Her 26 years in an industry dominated by men will bring an important perspective.

After nine months of intensive tutoring, she graduated from the program in January 2017. This made a dramatic difference in her life. Her exit exam scores were off the charts. She was finally testing at a college level. When she first made the PCC President's List, it was the first time in her life she felt intelligent. Now she volunteers with Start Making a Reader Today, to work with kids at Irvington Elementary who also struggle with reading.

Witnie is a strong woman, who will use her education to better the world. We will hopefully meet her in the spring, when we invite her to one of our meetings.

# Public Policy

# Ballot Measures – Take Action: Vote NO on Measures 103, 104, 105 and 106!!

When you receive your Voters' Pamphlet, you may notice AAUW of OR is listed as a signatory to the "NO" statements on measures 103, 104, and 105. It is important that you and your community are informed about what these Ballot Measures are all about, particularly as there is a lot of misinformation circulating about them.

<u>NO to Ballot Measure 106</u> – It would bar public funding for abortions, which not only restricts reproductive freedom and access to the full spectrum of reproductive services for those who receive coverage through the Oregon Health Plan, but public employees as well. If this Measure is passed, it is only the first step down the road to complete eradication of the right to reproductive choice.

NO to Ballot Measure 104 - It would extend the requirement for a 3/5th majority vote in both the House and Senate in order to enact tax exemptions, credits and deductions. Right now a 3/5th supermajority vote is required to raise revenue, i.e. taxes, and that provision will remain as is. The primary reason we oppose this Measure is that it just does not make sense to mandate fiscal policy via а Constitutional amendment. By focusing attention on each and every legislative vote, it also fosters the winnertake-all, hyper-partisan approach that our political parties feel they must adopt in order to enact their platforms. Even more importantly, we do not need to reduce funding for much needed care, social educational. health services, law enforcement and other services.

<u>NO to Ballot Measure 103</u> – It would prohibit state and local governments from enacting taxes on "groceries." The Measure is a remedy in search of a problem — there is no effort to impose sales taxes in general or sales taxes on groceries. "Groceries" are defined as "any raw or processed food or beverage intended for human consumption except alcoholic beverages, marijuana products, and tobacco products." The Measure also enshrines a special interest into a constitutionally mandated loophole, which is not a good way to govern and to manage state budgets. The main group pushing this Measure are manufacturers of sugary drinks and sodas. They want to counter a growing movement for cities to ban such products.

<u>NO to Ballot Measure 105</u> – This Measure would repeal Oregon law forbidding state resources from being used to apprehend persons violating federal immigration laws. Passage of Measure 105 could open the door to widespread racial profiling and is a "slippery slope" that might embolden those who seek to exclude "others." Nothing in the current law prevents federal authorities from apprehending those violating federal immigration laws.

# AAUW Fund Names and Numbers by Program Area

9110 — The AAUW Fund goes to where the need is greatest. Unrestricted gifts to this fund support existing programs and give AAUW the dexterity to act quickly and responsibly in the wake of any new challenges facing women and girls.

**4339** — The Leadership Programs Fund supports programs that develop women's potential to lead in their schools, communities, and country. It supports all the following tax-deductible programs:

- 2505 National Conference for College Women Student Leaders (NCCWSL) attendees develop their leadership skills, networks, and ambition at this three-day conference held annually in the Washington, D.C., area. Donations to this fund provide financial assistance to young women who would be otherwise unable to attend the conference.
- 2515 Campus Action Projects award grants to campus leaders who deliver programs guided by AAUW research to address a gender-based issue in their campus communities.
- 2522 Elect Her teaches young women leaders to run for student government and future office. This program has increased the number of women running for and winning campus positions.
- 4338 Start Smart. These salary negotiation workshops provide college women who are approaching the job market with the knowledge and skills to negotiate salaries and benefits.
