

#### From President Ilga Ross:

As the Coronavirus (COVID-19) unfolds, it affects us not only from a health standpoint but also socially, financially, politically and culturally. All of us must adjust as the pandemic moves through our community. The Tigard Area AAUW Branch will play our role in "flattening the curve" by following the advice of the pandemic and health department.



#### **Tigard Area Branch Cancellations:**

One of the strongest messages has been to avoid gatherings of people, especially older people, in order to reduce the spread of the disease.

Based on that advice, the **April 2nd NW Discoveries visit to Mahonia Hall and the April 8th branch meeting are canceled.** The branch Executive Committee will continue to evaluate beyond those dates and keep you informed. We are fortunate that all of our branch officers are elected for next year and can carry on without interruption.

The Book and Movie Interest Group leaders will be working with their own groups to determine their course of action through this period and will be reaching out to you with those decisions.

#### **AAUW of Oregon Cancellations:**

AAUW of Oregon has also been making decisions about programs and events. The AAUW of Oregon and Washington Dual Convention that was scheduled for April 17-19 has been canceled. The governors of both Oregon and Washington have declared states of emergency and have banned meetings of over 250 people. The Dual Convention was expected to draw about 200.

The AAUW of Oregon Executive Committee discussed the situation, and the full Board of Directors at their meeting on March 19th (held virtually via Zoom) voted to cancel outright. An option offered by Washington State AAUW to postpone until August was rejected. No decisions have been made yet about the Summer Workshop or the 2021 State Meeting.

Costs for the convention and hotel are fairly high this year and an attorney is being consulted regarding AAUW of Oregon's financial obligations to the hotel. Registration refunds are being issued to those individuals who have already registered for the convention. Those who have hotel reservations must cancel them on their own.

#### **Conducting State Business:**

Meanwhile, the business of the state organization must be conducted to meet legal requirements:

- 1. At the branch meeting, we elected Ilga Ross and Marsha Brockmeyer as our branch delegates, with Judy Silverforb as alternate. As requested, the credentials chair has been sent the names and email addresses of our voting delegates.
- 2. The business meeting will be accomplished by a Zoom meeting and e-mail.
- 3. Documents of import will be e-mailed to delegates prior to any Zoom meeting.
- 4. Instructions for what to do will be included with each e-mail.
- **5.** The Delegate Assembly and Annual Business Meeting will be held via Zoom on Sunday, April 19th, at 1 p.m. PDT. (Same day as originally scheduled at the convention.)
- **6.** Each delegate must use their own computer or tablet.
- 7. A Zoom practice session will be scheduled prior to the meeting for those who are unfamiliar.
- **8.** Agenda items will include the election of state officers and the nominating committee members and adoption of the new Public Policy Statement and State Strategic Plan.
- **9.** Attendance at this meeting is limited to delegates only, but the proceedings will be recorded for all members to view thereafter.



#### **Tigard AAUW Attends Lobby Day**

Randa Blanding, Carol Brenneman, and Ilga Ross recently spent an informative day at the Capitol Building listening to and talking with state legislators, listening to lobbyists, and interacting with other staff members and AAUW members from throughout the state.

The annual event was held on February 24th, the day that the Republican senators first walked out of the sessions in protest of voting on a controversial environmental bill under consid-

Our delegates definitely felt it was productive time and appreciated being able to meet with the staff of Ginny Burdick and Margaret Doherty, representatives in our area.
